### Performance Contract

Any songs requested less than three months before the performance, if agreed to by Johnsonville Brass, will incur fees in addition to the agreed upon fees listed in this contract. Likewise, please be advised that any special requests, made at any time, may incur additional fees.

In return, the Bride and Groom will supply Johnsonville Brass with 4 chairs and any other equipment necessary for the quartet to perform including \_\_\_\_\_.

The Bride and Groom will provide Johnsonville Brass with the agreed upon fee of \$\_\_\_\_\_, \$100 of which must be included with one signed copy of this contract in order to secure the performance date and time. This is a non-refundable deposit. The remaining \$\_\_\_\_\_, must be received by Johnsonville Brass no later than ten days before the performance.

If the event is cancelled less than ten days before the scheduled performance, all monies paid will be forfeited to Johnsonville Brass and any unpaid balances will still be due. Cancellation ten or more days

in advance of the performance, entitles the bride and groom to a full refund minus the \$100 deposit.

\*In case of inclement weather that prevents the above listed event from taking place, the quartet will play on the weather date of the \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_ at the time and location listed above. If the individual(s) booking Johnsonville Brass choose to waive the right to set a weather date when the contract is signed, and the event is cancelled due to weather, the quartet must still be paid. If the quartet decides not to attend, due to weather, the money, including the \$100 deposit, will be refunded.
